#### 4. First-aid measures

Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas.</p> <p>Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original container for re-use. For waste disposal, see section 13 of the SDS.</p>
<b>Environmental precautions</b>	Do not release into the environment (see section 12). Avoid discharge into areas not consistent with package labeling.
